

Children ages 3-20 are eligible for dental treatment at the Baker County Health Department. Children 2 and under are referred to a pediatric specialty dentist who has the special equipment needed for a child's small mouth. We accept several different Medicaid plans. Patients who are not Medicaid eligible are charged for services at the Medicaid rate. We are not able to accept dental insurance plans. Adults who are Medicaid eligible are seen for emergency visits.


Environmental Health

The primary purpose of Environmental Health is to prevent injury and disease by controlling the links between humans and their environment. Our agency continuously works to keep the environment around you safe. Environmental Health is located at the main Health Department site in Macclenny. The division offers the following:

- ◇ Regulation, permitting, and inspection of septic tank systems
- ◇ Regulation/Inspection of public swimming pools and bathing places
- ◇ Investigate complaints of sanitary nuisances
- ◇ Regulation/Inspection of group care facilities, migrant labor camps, recreational camps, recreational vehicle parks and mobile home parks
- ◇ Regulation/Inspection of food hygiene service facilities in schools, hospitals, child care centers, theaters, detention facilities, civic and fraternal organizations, group homes and bar/lounges
- ◇ Investigate cases and outbreaks of food or waterborne diseases.
- ◇ Regulation/Inspection of tanning facilities and massage establishments
- ◇ Information and consultation on residential indoor air quality and lead monitoring services
- ◇ Regulation Inspection of body art facilities and biomedical waste facilities

Health Education's goal is to provide educational support to promote positive healthy lifestyles. Through programs that focus on chronic disease and injury prevention, we educate and inform the public on a variety of health topics by conducting wellness programs, health screenings and health and safety initiatives.

Accomplishments include:

- ♦ **Diabetes Self-Management** classes provide diabetes education to county residents to improve their diabetes and quality of life. <http://www.diabetes.org/>
- ♦ **Safe Routes to School** program allowed school aged children a Walking School Bus to promote physical activity.
- ♦ **Tobacco Education, Prevention and Cessation** classes— Community/school education classes for minors who are ticketed for using tobacco on school grounds. Cessation classes for those who want to quit using any type of tobacco products.
- ♦ **Community and School Gardens** —encourage children and adults to grow, prepare and eat fresh produce. Children who have a garden in their classroom are responsible for the upkeep of the garden and learn how to prepare fruits and vegetables they have grown.
- ♦ **CPR/First Aid, Babysitting and Healthy School** programs.
- ♦ The Wyman **Teen Outreach Program (TOPS)** strives to reduce teen pregnancy, decrease school suspensions and course failure by teaching positive youth development such as decision making skills and community service activities.
- ♦ **The Abstinence Program, "Be a Better Man"**, teaches teens and young adults the importance of positive relationships and the consequences related to risky behaviors, such as unplanned pregnancy and sexually transmitted diseases.
- ♦ **"COOL: Changing Our Own Lives"** for young adults 11-17 years old—empowering teens to build assets and receive information about sex, drugs, dating, teen anger, bullying and using positive life choices

Health Educators teach classes and seminars, attend health events and design and distribute materials to improve health outcomes in the community. We form community partnerships and seek to create policy and environmental changes throughout the county that will benefit the health of our residents.



Epidemiology

A communicable disease or condition may be transmitted directly or indirectly from person to person. Communicable disease outbreaks and risks usually receive widespread media attention and community interest. The Department of Health is the first agency to be contacted when conditions point to communicable diseases.

The staff at the Baker County Health Department is trained to assess, evaluate, and monitor reports of communicable diseases to prevent epidemics. This helps to control outbreaks of disease, and minimize the threat to individuals, family members, and the entire community.

W.I.C.

WIC is a special supplemental food and nutrition education program for Women, Infants, and Children.

Who is eligible?

- * A pregnant woman
- * A breastfeeding woman
- * Non-breastfeeding woman whose infant is less than 6 months old
- * An infant or a child under 5 years old
- * Have a low or moderate income (you do not have to be on public assistance to qualify)
- * Be at nutritional risk



What do I need to qualify?

You will need a height and weight measurement and a blood test for hemoglobin or hematocrit from a doctor.

WIC helps because it provides:

- * Healthy foods
- * Nutrition Education
- * Breastfeeding information and support
- * Healthcare Referrals

Even working families may qualify for WIC.

Adjusted income eligibility guidelines are used in determining the income eligibility of persons applying to participate in the WIC Program. Contact the Local WIC office for financial determination and program eligibility.

VITAL STATISTICS

You can obtain a Birth and/or Death Certificate Monday-Friday, 8:00 am—4:00 pm

Birth Certificate

- \$15.00 for Baker County births.
- All other Florida counties from 1930 to present are \$15.00 each certified copy.

Birth certificates are confidential in the State of Florida and can only be issued to the registrant if 18 years or older, parents listed on the birth certificate or guardian with legal guardianship papers.



Death Certificate

Death certificates can be obtained for those who have died in Florida 2010-present.

- \$10.00 each certified copy
- \$5.00 Expedite Fee

To obtain either a birth certificate or a death certificate for a person born in Florida or deceased, you will need to:

- Complete a certificate application
- Provide proof of identification
- Meet minimum age requirement of 18 years old

Disaster Preparedness

Public Health Emergency Preparedness focuses on planning coordination and program development that protects the health of Baker County's citizens and residents from the effects of both man-made and naturally occurring events. Efforts range from special needs shelter planning to providing assistance to citizens that may require special care during tropical weather, to planning for mass distribution of medications to protect us from disease outbreaks. We coordinate with local and regional partners in the development of response plans to provide the best possible means to ensure that our citizens are protected.

Florida’s Healthy Start initiative was signed into law on June 4, 1991. Healthy Start legislation provides for universal risk screening of all Florida’s pregnant women and newborn infants to identify those at risk of poor birth, health and developmental outcomes.

In Baker County, we deliver services by phone, office visits or by home visitation. The program participants and Healthy Start staff decide jointly which forms of service delivery will be most beneficial for clients to receive. An interdisciplinary team of a Licensed Clinical social worker and health educator provide the following services:

- ◆ Childbirth and Postpartum Care Education
- ◆ Care of the Newborn Education
- ◆ Breastfeeding Education and Consultation
- ◆ Supportive Counseling
- ◆ Smoking Cessation
- ◆ Reference Library
- ◆ Car Seat Safety Program
- ◆ Referrals
- ◆ Safe Sleep Promotion for Infants
- ◆ Parenting education classes and support

The Baker County Healthy Start Program is *committed* to the goal of reducing infant deaths and the number of low birth weight babies born to the women of this community. The Baker County Health Department participates in and facilitates the Infant Mortality Task Force, Fetal Infant Mortality Review, and Teen Pregnancy Prevention Coalition to address health disparities and issues.



School Health



The mission of Florida's School Health Services program is to appraise, protect and promote the health of students. Preventive and emergency school-based services are provided to public and private school children in grades kindergarten through twelve.

School nurses enhance health within the school and community by providing health appraisals, nursing assessments, immunizations, nutrition assessments, preventive dental services, periodic health screenings, health counseling, referral and follow-up of suspected or confirmed health problems, emergency health services, and promoting activities to reduce risk-taking behaviors.

Every year, School Health conducts Student Health Screenings where they look at vision, hearing, scoliosis, and BMI (Body Mass Index). We are improving the health of our students and we use BMI's to measure our success. BMI screenings are conducted in the First, Third, and Sixth Grade. Each student is categorized by their age and they fall into percentages.

CHIP

The Baker County Community Health Improvement Plan (CHIP) was developed as a result of the collaborative efforts by Baker County employees, expert consultants, health care leaders, public health professionals and other vested stakeholders that make up Healthy Baker, the county's formalized leadership council for health improvement.

This Plan is designed to address weaknesses and build upon strengths identified in the community health assessment and provide a clear course of direction for the future of Baker County's Health. The purpose of this plan is to describe the short, mid, and long-term strategies and activities related to the targets associated with each community health indicator and to establish priorities and objectives over the next four years.

CHA

The Community Health Plan (CHA) was put together following a two-year long process of collecting and analyzing data, engaging and mobilizing key constituents, and developing multiple reports to depict the state of health in Baker County. This collaborative process has resulted in both quantitative and qualitative methods to systematically understand health within our community. It has informed our staff and our community regarding forces of change, community strengths, and opportunities for improvements to affect the quality of life for Baker County residents.

STRATEGIC PLAN

The Strategic Plan outlines our purpose, the priorities for the year and how we will deliver them for the benefit of the public. This Plan is a living document that builds on what we have learned and experienced as an agency over the years. The Plan will continue to be refined and perfected as we deliver health services to the public and continue to be the medical home for many individuals and families in this community.

The Strategic Plan represents a challenging work program for the upcoming implementation period, one that will deliver tangible benefits, offer the highest quality services to our community and fulfill our role in the coordination of local public health functions.
